You are also hereby requested to submit the facts and information with details on the day of sitting.

Please take notice that in case you do not attend the Sitting with details, the Commission may exercise the powers of Civil Court conferred on it under Article 338A of the Constitution of India and issue summons for your appearance in person or by a representative before the Commission. It is therefore requested to kindly make it convenient to attend the Sitting in the Commission on the Scheduled date and time with all relevant records in the case.
