4. Further, it is requested to bring all the relevant records/files in the matter for placing before the Commission as would be necessary during the Sitting.

5. Please take notice that in case of failure to attend the Sitting, the Commission will be constrained to exercise the powers of civil court conferred on it under Clause (8) of Article 338A of the Constitution of India and issue summons for the appearance in person before the Commission.
