Record of Proceedings of the Sitting taken by Shri Bheru Lal Meena Hon'ble Member, NCST on 28/05/2013 at 11.30 Hrs in the NCST with officers of the Ministry of Railways on the representation of Shri Mohan Lal Meena, CIT, Lucknow.

1. The Sitting was chaired by Shri Bheru Lal Meena Hon'ble Member, NCST with officers of the Railway Board and Northern Railway, on the representation of Shri Mohan Lal Meena, CIT, Lucknow.
2. The list of officers who attended the Sitting is attached. The petitioner was also present in the Sitting.
3. The petitioner Shri Mohan Lal Meena, CIT, Northern Railway, Lucknow has forwarded a representation dated 31/08/2012 in the Commission in which he mentioned that no action has been taken by the General Manager, Northern Railway, Barod House, New Delhi on the decision taken in the record proceedings of the Sitting held in the Commission on 14/03/2012. It was mentioned in the record proceedings of the Sitting held in the Commission on 14/03/2012 that the Railway Department had awarded major penalty instead of minor penalty on Shri Mohan Lal Meena without giving him a charge-sheet which is injustice. The Commission had advised the Railway authorities to produce copy of charge-sheet or disciplinary action taken against the petitioner. However, no action had been taken by the Railway authorities in this regard. The petitioner had requested the Commission in his representation dated 31/08/2012 to re-fix a Sitting with the Railway authorities. The Commission observed that despite sending several reminders to the Ministry of Railways, no satisfactory reply was received.
4. Shri S.S. Sandhawalia, CPO/IR-N.Rly submitted that the issue of Shri Mohan Lal Meena has been resolved and he has been promoted as JIT/Dy CIP in grade Rs. 5500 9000/- with effect from 24/02/1999 on proforma basis and actual from 09/04/2001 vide DRM/LKO Office Order No. E/6-8/Ticket Checking/11 dated 27/05/2013. He further informed that Shri Mohan Lal Meena has also been promoted as CIT with effect from 24/02/2001 on proforma basis and actual from 01/11/2003 on completion of two years service as JIT/Dy CIT i.e 24/02/2001. Consequently, the seniority of Shri Mohan Lal Meena has also been assigned below Shri Hari Singh Meena and Shri Gulab Chand and above Shri A.A. Jaisi in the seniority list issued on 01/05/2013. Accordingly, his pay has also been fixed subject to vetting of associate account.
6. The Director, NCST asked Shri Mohan Lal Meena whether he has received copy of Northern Railways Office Order No. E/6-8/Ticket Checking/11 dated 27/05/2013. Shri Mohan Lal Meena confirmed that he has received copy of the Northern Railway Office Order dated 27/05/2013 and he is satisfied. However, he asked when the arrears of his pay fixation will be paid by the Railway authorities. Shri S.S. Sandhawalia, CPO/IR-N.Rly submitted that arrears of his pay fixation will be paid in due course.
7. The Hon'ble Member, NCST advised the Railway authorities to pay all the arrears due to the petitioner consequent to his retrospective promotions within a period of one month. Action taken report in the matter be submitted to the Commission within 30 days by the Railway authorities.
8. The Sitting ended with vote of thanks to the Chair.
