Please refer to this Commission letter of even number 10/09/2012, seeking presence of Principal Secretary to Govt. of India, U.P., Deptt. of Social Welfare **in person** for the Sitting scheduled to be held on 04/10/2012 at 1200 hrs. in connection with the representation dated 03/11/2011 received from Shri Rajesh Kumar, S/o Shri Hira Lal r/o Mohalla Harpur Nai Basti, Post Sadar, District Ballia, (UP) regarding cancellation of ST certificates issued to Brahmins, Nayaks, and Brahamins Ojha community in U.P.

2. Principal Secretary, Deptt. of Social Welfare was advised to appear in person for the scheduled Hearings on 22/8/2012, 7/9/2012, and 4/10/2012. However Principal Secretary did not appear in person for one or the other reason. Therefore, Chairperson, NCST has noted with great concern the absences in the scheduled Sitting and also production of a letter dated 28/09/2012 from Shri N.H. Rizvi, Dy. Secretary, Govt. of UP, addressed to Shri T.D. Kukreja, PS to Chairperson, NCST wherein Shri Visheshwar Singh, Dy. Director, Social Welfare Deptt. has been directed to attend the Sitting and petitioners have been asked to furnish the details of persons who have been issued ST certificates. You may be aware that the Commission has powers of a Civil Court, inter-alia, in summoning and enforcing the attendance of any person and production of any document in connection with investigation into any matter.

3. The next Sitting of the Commission has been scheduled for Wednesday, the 17th October, 2012 at 1230 hrs. Shri Visheshwar Singh has been apprised of certain detail/documents, as under, which are required by the Commission before the scheduled Sitting.

- i) Recommendations of the Training and Research Institute of the State Government regarding inclusion of the Nayak and Ojha Caste in the list of the Scheduled Tribes.
- ii) Basis of issue of G.O. dated 3/7/2003 by the Govt. of UP.
- iii) Full details of G.O. dated 30/9/2003 by which the G.O. dated 3/7/2003 was cancelled.
- iv) Number of persons who got employment on the basis of false certificate and details of removal from the service obtained on the basis of false ST certificates.

4. It has been informed by the officials of State Govt. that you have been assigned the Charge of Principal Secretary, Social Welfare Deptt. Govt. of U.P.

5. Accordingly it is requested that you may make it convenient to attend the Sitting personally, which is scheduled on 17th October, 2012 with all requisite details/documents before the Commission.
