Proceedings of the sitting on 19-01-2010 of Hon'ble Member Shri Tsering Samphel with Registrar, DTU

ISSUE

Notification of appointments to the posts of Lecturer without reservation for STs under Delhi Technological University, Delhi.

BACKGROUND

A notification of appointment to the posts of Lecturer without any reservation for Scheduled Tribes in various disciplines under the Delhi Technological University, Bawana Road, Delhi was notified on the University's website 'www.dce.edu'. There were 92 vacancies in 19 departments of the University and reservation was there for SCs and OBCs but for Scheduled Tribes.

Considering the importance of the matter, Shri Tsering Samphel, Hon'ble Member decided to have a discussion with Principal Secretary, Education Department, Govt. of NCT of Delhi and Registrar, Delhi Technological University, Delhi in the matter on 19.01.2010 in the Commission.

DISCUSSION

The Registrar, DTU submitted a status report on the issue and explained that there were 7 posts of Lecturer in different disciplines earmarked to ST category as per the Reservation Roster followed in the University. The recruitment against these 7 ST vacancies has been kept in abeyance till such time the reservation policy is notified by the Govt. of Delhi.

The Commission was further informed that Hon'ble Supreme Court in their judgement on 04.08.2009 in Subhash Chandra & Ors Vs DSSSB & Ors upheld that no presidential declaration exists under article 342 of the constitution listing STs for the UT of Delhi. In view of the said judgement, the DTTE & DTU sought a clarification from the Hon'ble Supreme Court by filing IA No. 7-12 in the matter reason being the reservation for ST category was announced in the Bulletin of information published by the Faculty of Technology, University of Delhi for admission in BE program for the session 2009-10 in the erstwhile DCE now DTU & NSIT. Hon'ble Supreme Court vide their order dated 13.11.2009 permitted admission of ST category in both the institutes for the academic session 2009-10. File No. 24/10/2009/STGDH/SEOTH/RU-I

Accordingly, admissions were made for ST category candidates separately. However, the reservation policy for the academic session 2010-11 is yet to be notified by the Govt. of Delhi.

RECOMMENDATION

In view of the position as explained by DTU, the Commission recommends that a recommendation may be forwarded to the Chief Secretary, Govt. of NCT of Delhi to advise all the departments of Govt of Delhi, not to fill up the ST reserved vacancies as per the Post Based Roster by other categories and keep them in abeyance till such time the reservation policy is notified by the Govt. of Delhi, as followed by DTU.
