
TOUR REPORT OF SHRI HARSHADBHAI VASAVA, HON'BLE MEMBER,

17.01.2017 (Tuesday)

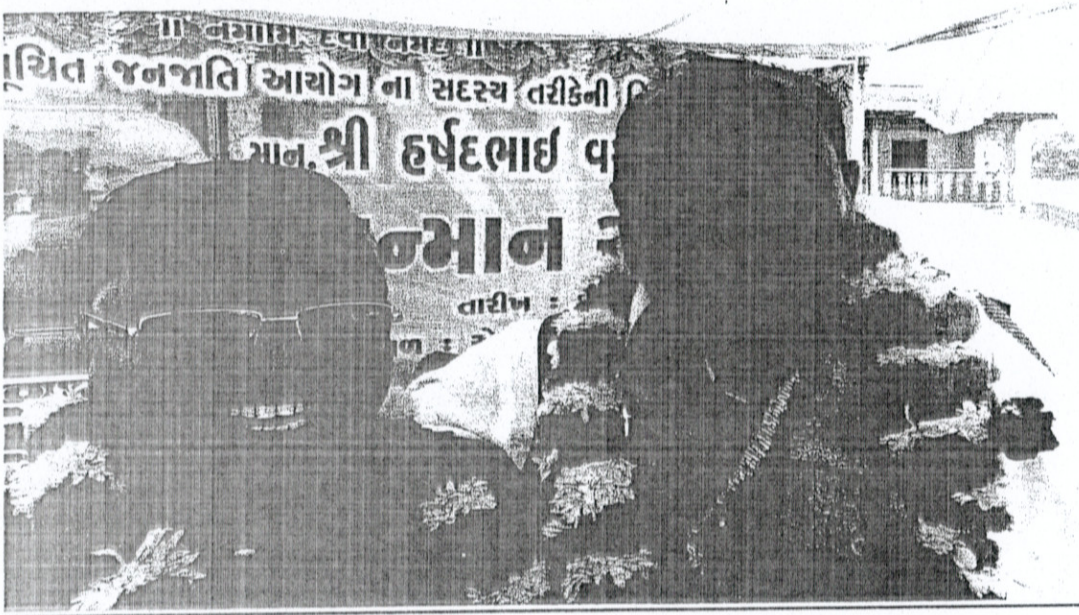




19.01.2017 (Thursday)

assured them of extended support from my end as and when needed. I also briefed about the Commission's rules and regulations which have to be followed by both of us for the overall development of the community.


21.01.2017 (Saturday)

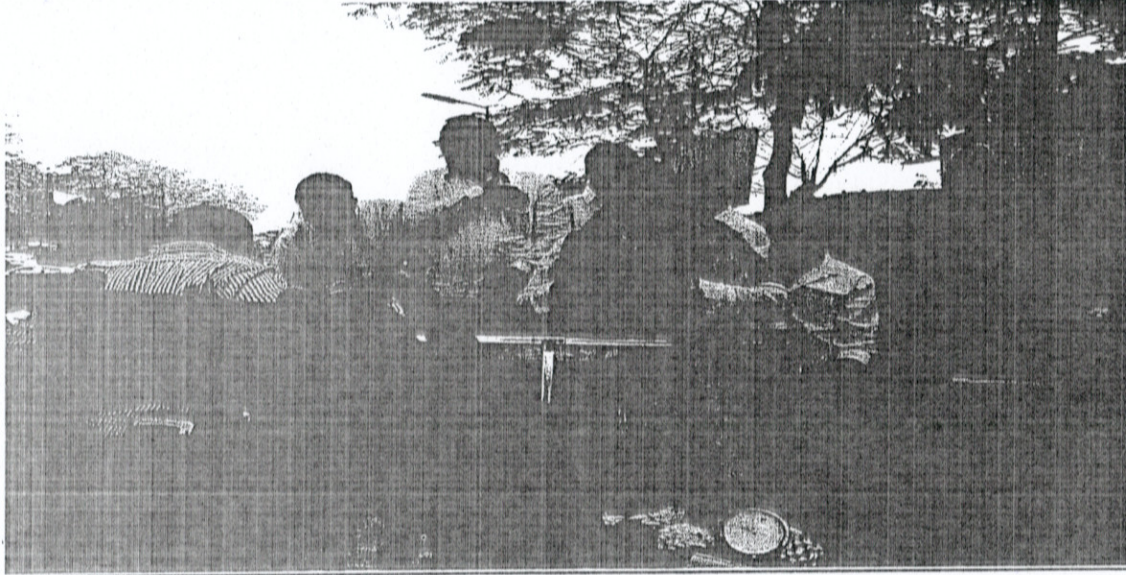
23.01.2017 (Monday)
